However company had appointed an independent Director. Presently the Company has 2 Independent Directors and 4 Non Independent Directors of which 1 of them is Non Executive Vice Chairman. Hence in the absence of appointment of Independent Director as new Chairman, the compliance of stipulation on the composition of the Board as per Clause 49(1A)(ii) of the Listing Agreement is yet to be fulfilled. In view of coming into effect of the Companies Act, 2013 w.e.f.1 st April, 2014 the number of directorship a person can hold, though increased to 20 companies the same includes Private Limited Companies and this has restricted us from proceeding with induction of a new Chairman since availability of independent director matching with size and nature of the organization has reduced. The company is endvouring to appoint Independent Director / Chairman by end September, 2014
